# DEDICATING THE FREED CENTER FOR LEADERSHIP AND SERVICE

### THE JOURNEY TOWARD THE DEDICATION OF THE FREED CENTER

FOR LEADERSHIP AND SERVICE ON OCTOBER 4, 2024 BEGAN SEVERAL YEARS AGO AS ALL MAJOR BUILDING PROJECTS DO. FROM THE INITIAL IDEA TO THE OFFICIAL RIBBON CUTTING, A THREAD THAT TIES THE ENTIRE PROJECT TOGETHER IS A POSTURE OF THANKS AND WORSHIP.

"Vanguard University is deeply grateful to the Freed family. As a result of their gracious gift, we will now have a home for our burgeoning kinesiology program and a space where student athletes can learn and refine resilience in body and spirit," said Vanguard President Michael J. Beals, Ph.D. "We see a bright future where we can better serve generations of students and coaches, providing student-athletes a space for the highest levels of athletic competition; where they can grow individually and as a team."

At the "Farewell to the Pit"–the beloved, 80-yearold gym that stood on the same location as the Freed Center now stands–event in April of 2022 and the groundbreaking for the Freed Center in October of 2022, the VU community gathered to celebrate the past and look toward the future.

"Since the early 60s, The Pit has been part of the heart of Vanguard," said Vanguard President Michael J. Beals, PhD. "Generations of student-athletes and fans have made wonderful memories in our beloved gym; and we're glad we gave it the appropriate farewell. I'm confident that the Freed Center will provide a dynamic space for our community to gather and forge new memories."

And the Freed Center is already doing just that: the first athletic competition was held in the gym on September 20 when Vanguard's women's volleyball team took on Azusa Pacific, the five new classes and two labs are filled with students and teaching, and the weight room and sports medicine facilities are in full use.



"Competing in the Freed Center will help our team tremendously," said junior men's volleyball player Logan Finlay. "Having a dedicated home gym will not only boost our morale, but also provide us with a consistent and familiar environment to practice and compete in. I hope the Freed Center becomes a hub of excellence for our volleyball program and other sports, and that it can become something that our community can bond over and love!"

"I am very excited to actively witness how our new facilities can both cultivate and optimize a dynamic learning environment for all of our Kinesiology major students," said Paul Hwang, Ph.D., assistant professor and kinesiology department chair. "The Freed Center provides so many blessings for our Vanguard University community. The multitude of new laboratory equipment, larger classroom spaces with active learning modalities, as well as the myriad of student lounge spaces for encouraging community and collegiality amongst peers significantly elevates the educational experience for our students."

During the dedication ceremony, senior Amberly Gourlay, president of the student government association, reflected on the significance of the 60,000 square-foot building. "This moment feels like the culmination of what God has been saying throughout my time at Vanguard, which is to seek first my kingdom and righteousness and all





# JOB SHADOW: Vanguard Alumni invest in student careers

One of the most valuable aspects of a Vanguard University undergraduate education for many students is the ability to pursue a career that inspires them to make a difference for Christ. Whether they are working toward a degree in business, nursing, or the arts, VU Lions are a part of a greater community of students and professionals—one that understands the importance of each contributor using their unique talents in the world.

Vanguard's Job Shadow program is expanding on this benefit. Through this program, undergraduate students can develop a deeper understanding of their career path while strengthening connections with VU alumni. In this program, students are connected with a mentor professional in the field they aspire to, and then can shadow them at their job for a single day.

Kayli (Cotten '06) Hillebrand, D.Ld., associate dean of career development and experiential education at Vanguard, shares how the program gives students a broader context for their chosen career. "This highimpact program not only provides the benefit of meeting with an industry professional,

but it also introduces them to potential businesses and organizations for internships and jobs while expanding their professional network."

While building connections with the potential for future work is an attractive feature of the program, the one-day time commitment can be just as much an asset for students. "I chose to participate because this isn't like an internship where you are under a long-term contract," shared Job Shadow participant and business administration major, Samantha Esparza '27. "This is a one-day activity, making it a fast way of knowing whether you enjoy the career industry you are looking at."

For students seeking confirmation that they are on the right career path, getting real-world experience in the field provides invaluable insight that they would not get from the classroom. "I will often tell students that discovering you don't like something is as much of the Lord shaping your path as identifying the things you do like," explains Hillebrand. "At times, the perception of a professional role and the realities of it can differ this program allows students to

peek behind the curtain prior to committing at a vocational level and adjust if needed."

Students can participate in the program as often as they feel they need to. Those who change majors or shift their goals for the future can continue to reap the program's benefits as they more clearly define their pursuits. For others who feel confident in their career path, revisiting the program can allow them to shadow several roles and develop a well-rounded industry context. Business administration major Jonathan Tribble '26, is a returning participant of the Job Shadow program. "I had the opportunity to shadow an employee at Boeing [last year]. It was an incredible and insightful day. [This year], I hope to confirm and correct my assumptions about the career path to help me better understand if this is something that I could see myself doing," he says.

One of the most advantageous aspects of Job Shadow is that many mentors offering shadowing opportunities are Vanguard alumni. With a deeper understanding of students' experiences, they offer genuine guidance beyond simple career advice. Nicole (Thompson '95) Suydam, president and CEO of Goodwill of Orange County and Job Shadow mentor, shares her heart for supporting Vanguard students in their career pursuits. "I see these opportunities as a game changer for students to network with business leaders and learn what it takes to start and grow their careers," she says. "It's such a joy to see the expressions on their faces as they are touring our operation and learning something new."

Building relationships with others in the Vanguard community who genuinely want to invest in their professional and academic development can also give students confidence in their academics. "As students connect to a future career or industry and truly begin to see their path toward that goal and calling, their intentionality with their academics and the broader community flourishes in a way it didn't before," shares Hillebrand. Despite its relatively recent establishment at Vanguard, the program has shown to be dually beneficial—encouraging students in their current academic studies while synonymously empowering them for a future career.

The Job Shadow program thrives because of a community of professionals investing in the growth of the next generation of Vanguard graduates. WHILE A QUALITY CHRISTIAN EDUCATION SIGNIFICANTLY BOOSTS THE VALUE THAT STUDENTS WILL BRING TO THEIR FIELD, SETTING THEMSELVES APART IS CRUCIAL TO SUCCESS IN BOTH THE SHORT AND LONG TERM.

Julius Agbor, Ph.D., professor of finance and economics, is playing a major role in supporting business students as they round out their resumes and prepare for graduation. Following his leadership in the 2023 Giving Day initiative to provide several Patty Arvielo School of Business and Management students the opportunity to obtain either a Real Estate License (REVEI) or Certified Commercial Investment Member (CCIM) designation, he continues to mentor students as they earn micro-credentials to supplement their bachelor's degrees. "Real estate is not just an important foundation of the U.S. economy and California economy in particular, but also probably the most resilient sector to business cycle fluctuations," explained Agbor. "As a significant investment vehicle, everyone has a stake in it, whether owners or investors.

With business degrees from the University of Yaoundé II in Cameroon, the University of the Western Cape, Cape Town, and the University of Cape Town, South Africa, as well as extensive experience in global business and trade, Agbor offers specialty guidance and mentorship to students seeking a well-rounded business education that serves a powerful purpose in God's kingdom.

Whether specific to real estate or not, micro-credentials show future employers specific, targeted areas of education and professional expertise. Students may choose to earn specific types of micro-credentials, highlighting their interest in a particular area. Adding microcredentials to one's resume also shows initiative, showcasing soft skills like creativity, problemsolving, and continued learning. "Micro-credentials generally help graduates' skills become more marketable, as these credentials are often industry-certified. They also showcase evidence of mastery of specific areas, if not interest and passion," said Agbor. For students who are seeking a career in a niche sub-industry, this can be extremely helpful in setting them apart among competitors.

A secondary aspect of Agbor's Giving Day initiative was to fund the opportunity for several School of Business and Management students to present original research at the 2024 International Business Ethics and Sustainability Case Competition (IBESCC), which took place April 8-12, 2024, at Loyola Marymount University in Los Angeles. Contributing to an industry conference of this size not only prepares students for potential graduate work but also hones critical thinking and analytical and oral skills, according to Agbor.

When students are challenged to move their classroom learning to real-world application, it gives



them confidence in their professional skills and adds a distinct accessory to their business portfolio. They also have the opportunity to network with others in the industry and establish their professional position early in their career. With more professional experience in their back pocket, students have more career opportunities upon graduation.

The Giving Day Initiative raised \$3,085 and made a major impact in the lives of numerous students. As a tenured professor with a rich background working in government, academia, think tank, and the private sector, Agbor has a unique understanding of how supplemental educational opportunities such as these can make a difference in the lives of up-and-coming business professionals "Exposure to research competition on such an international scale cannot leave one the same, much like a micro-credential that fast-tracks one's professional development," he explained.

# A YEAR OF CIVILITY

Election years are teachable moments on college campuses, where students are often in the midst of establishing their own opinions and building a political stance. Throughout the Fall 2024 semester, Vanguard University hosted several student events, together known as the "Year of Civility". This program is designed to foster thoughtful conversations and promote dignity, respect, and humility among students. Events include things like fireside chats, Bible studies, and leadership practicums to help build media literacy and promote respectful engagement. "The nature of our small campus lends itself to building meaningful community, and we want to see that community flourish, especially as we work through the tensions of an election year," said Jess Van Winkle '20, assistant director of student development and success. "Our student leaders will be pressing into the picture of community in Ephesians 4:2 and learn what it means to 'bear with one another in love' this year."

Vice President for Student Affairs Amanda Lebrecht is leading the charge for the program alongside the newly elected Student Government Association President

Instead of focusing on what was broken and needed to be fixed, she positioned herself as a student of those around her, seeking to learn from and unify various groups on campus. Her election campaign included five pillars: bearing witness to God's glory, bonding the student body, boosting the voice of the student body, building an international student community, and bringing awareness to any pressing needs that may arise.

"I think the idea of conversation and elevating the students' voices go hand-in-hand," expressed Gourlay. "Understanding and recognizing that every student has a voice and a seat at the table, while also having this general theme of encouraging people to speak out and have an open dialogue—that's something I'm super passionate about and excited for."

As an international student, Gourlay brings a unique perspective on politics to the table. While, admittedly, she came to the U.S. somewhat naive to the role that politics plays in conversations, the pride she has in her own country is steering her hope for driving out apathy and renewing a sense of initiative on campus. "One of the things [Amberly] talked about in her speech was about...how South Africa approached apartheid and how they used something that could be very contentious to bring the country together and solidify their commitment to one another," Lebrecht said. "I think [her becoming SGA president] is kind of a 'for such a time as this' moment as well."

While the Year of Civility is not Gourlay's primary focus, she sees it as a unique opportunity to hear and learn from her fellow students and be an example for fostering harmony on campus. Looking forward, Gourlay hopes that the experiences students have this year become the foundation for a lifetime of respectful civil engagement. "I want to encourage all students that they have a voice in any election year, that their vote matters, and that these things are important to discuss, but it doesn't have to be an aggressive argument. It can be a healthy discussion and debate," she said.



Lebrecht shared similar sentiments about the future of Vanguard's student body, "I hope that it will help them to think critically and further develop their political ethics, and begin to think, 'who do I want to be in these spaces? How do I want to show up in these spaces? What do I value?'" Perhaps more than ever, Vanguard students have an opportunity to be a light to others through the way they respond in politically controversial environments. Year of Civility events offer groundwork for building citizenhood, while the Vanguard community creates opportunities in and out of the classroom to engage in thoughtful, respectful conversation about current politics.

Gourlay pointed out that, as students at a Christian university, Vanguard students have a responsibility to put God first, even in their political stances and conversations. "I really hope we have the narrative of seeking Him first and everything else comes second," she explained. "Keeping him on the throne of our lives and recognizing that at the end of the day, we have that eternal hope."

The Year of Civility was designed to take place from the spring semester of 2024 through November 2024, and included speakers such as Eugene Cho, author of *Thou Shalt Not Be a Jerk*, and Nathan Gonzalez '00, editor and publisher of Inside Elections. Specific topics for discussion included recognizing bias, how to critically analyze news media and social media, migration and immigration, and more.

# LEADERSHIPTRAQ GIFT ENHANCES STUDENT LEADERSHIP DEVELOPMENT

Whether students enter Vanguard University pursuing a degree in biology or music, nursing or education, their academic journey is infused with the university's mission "to pursue knowledge, cultivate character, deepen faith, and equip each student for a Spirit-empowered life of Christ-centered leadership and service." Curricular and co-curricular experiences help students discern their purpose and strengthen their skills to contribute to their communities as leaders is crucial to delivering a valuable education.

From all corners of the university's offerings, students are offered opportunities to learn and practice Christcentered leadership skills. A recent leadership-level gift from Mick and Louise Ukleja of LeadershipTraQ, a leadership-consulting organization based in California, will infuse resources and unify the many existing opportunities to participate in leadership growth and development education.

- MICK UKLEJA, PH.D., Founder and President of LeadershipTraQ "From a theological perspective, leaders are raised up by God and nurtured in community," said Chip Espinoza, Ph.D., dean of strategy and innovation at Vanguard. "By bringing LeadershipTraQ to Vanguard, we're giving students a head start on learning about leadership."

Nearly half of Vanguard students already participate in leadership roles or training. The LeadershipTraQ gift will coalesce campus leadership opportunities, connecting them with curriculum and training. In the Spring of 2025, several campus groups will participate in LeadershipTraQ training, including students serving in roles in Residence Life, Student Engagement and Inclusion, Spiritual Formation, and the Student Government Association. In addition to students, faculty and staff will be offered LeadearshipTraQ curriculum focused on career-development.

"Vanguard has always impressed me with how they value leadership in the lives of all their students and in everything they attempt," Mick Ukleja, Ph.D., founder and president of LeadershipTraQ. "It starts at the top and trickles down to the students. Everything rises or falls with leadership, beginning with the belief that you cannot lead others until you lead yourself."

As emerging leaders, students often face complex challenges and dynamic work environments that require not just technical expertise but also the ability to inspire, influence, and guide others in a way that respects diverse personalities in the workplace. Strong leadership skills enable them to take initiative, foster teamwork, and drive innovation, all of which are essential for career advancement and organizational success. Dr. Ukleja points out that leadership in a professional sense is just one piece of the puzzle; it's also an opportunity to deepen their character and use leadership as a tool to be a light in their communities. "Leadership creates culture; culture creates behavior; therefore, work on leadership because that changes behavior," he shared. By gaining access to leadership development skills, students are doing far more than giving themselves a leg up in the workplace. They are shaping their personhood, building skills to be valuable members of society, and discovering what it looks like to be in community with others.

Leadership does not always look like being the one in charge. Being a strong leader can mean stepping back to let others challenge themselves, or even encouraging healthy communication in a lower-level department. "Leadership is two sides of the same coin—leader and follower—working together to accomplish a common goal. It's a dynamic process, and everyone gets better," Ukleja explained. "The line between the leader and the follower blurs when leadership moves people toward a common goal."

"Vanguard students will have a competitive advantage over their peers, because they're going to understand not only the leadership lingo, but also how to present themselves and how to do a quick assessment of situations," Espinoza explained. "Think about how that can help you at that first company you're going to work for."

The gift from Mick and Louise Ukleja to establish LeadershipTraQ at Vanguard marks a transformative moment for the Vanguard community and legacy, empowering students to excel as Christ-centered leaders and contribute positively to society.

# VANGUARD AND THE Samueli foundation partner to bring trafficking prevention to oc schools

In June 2024, Vanguard University's Global Center for Women and Justice (GCWJ) was awarded an \$825,000 grant from the Samueli Foundation. Founded in 1988, the Samueli Foundation is a Southern California-based private foundation whose mission is "to make Orange County a thriving mosaic of community well-being by supporting and uniting catalytic forces whose innovations yield a higher quality of life for everyone."

"We are immensely grateful to the Samueli Foundation for this generous grant, which will allow us to bring vital human trafficking awareness and prevention resources directly into Orange County classrooms," said Global Center for Women and Justice Director Sandra Morgan, Ph.D. "This innovative program will empower hundreds of students with the knowledge to recognize exploitation and skills for staying safe."

This grant, which is the result of a developing partnership and collaboration with the Samueli Foundation to address human trafficking, allows Vanguard and the GCWJ to launch the pioneering "Safe Communities; Safe Kids" (SCSK), bringing evidence-based, peer-topeer prevention strategies to Orange County schools, implementing California laws for human trafficking prevention education.

Through the Safe Communities; Safe Kids program, Vanguard University students will be hired and trained as peer educators to deliver an interactive curriculum on recognizing trafficking risks and building healthy relationships. Throughout the next three years, these student facilitators will reach hundreds of middle school students across Orange County. With Safe Communities; Safe Kids, Vanguard students continue their legacy of participation in such initiatives. Beginning in 2006, students on Live2Free teams (a club that empowers and trains college youth to raise

awareness, be peer-to-peer mentors, and be student abolitionists on the issue of modern-day slavery) have been present in schools, participated in study abroad trips, and strengthened research and education opportunities in the classroom with the Women and Justice Minor.

In addition to educating youth, the SCSK program will provide professional development for teachers. Educators will participate with their students, equipping them with additional tools to build sustainable school-based prevention models.


Vanguard continues to impact the local and global community by equipping students to become leaders in combatting exploitation through interdisciplinary courses and practical experience. The Safe Communities; Safe Kids program will take the GCWJ to a new level to *"Study the Issues. Be a Voice. Make a Difference"* as it educates VU to serve the community to build strategies for keeping children safe.

# ALUMNI SPOTLIGHT: MATTHEW KENSLOW '24

One of the challenges that many students face entering college is choosing a career path. And as technology rapidly advances, the options available are becoming even more diverse. According to the National Center for Education Statistics, about one-third of college students change their major at some point. But for Matthew Kenslow '24, his professional calling has always been clear.

"I've wanted to be a teacher since I was in first or second grade; I had those passions inside of me. I remember playing school at home and teaching what my teachers taught," he recollected. "I believe this is what God has called me to do."

In addition to the fulfillment he gets from helping students develop a deep understanding of the curriculum, Kenslow believes he has a unique perspective in the



classroom. As a person on the autism spectrum, he has learned how to use his experience to cater to students' diverse needs. "I have first-hand experience of how learning can be difficult for some students. Of course, everyone's unique and different," he explained, "but there are also overarching themes that people with autism tend to have."

Kenslow is embarking on a journey to educate students in a way that best serves them while "shining the light of Christ" wherever he goes. He seeks to create a classroom that feels like a safe space for learning and asking questions, where learning feels like an exciting opportunity rather than a burden.

While pursuing his bachelor's degree in biochemistry and master's in education at Vanguard, Kenslow has had the opportunity to explore different ways to engage with students. "I've learned a ton of things I didn't know, like UDL, which is universal design for learning, SEL, social and emotional learning, and different ways to reach every student despite their background," he said.

Kenslow's hope is to use his experience to help students feel comfortable in the classroom and be an advocate to help them overcome challenges. One way he does this is by speaking at school assemblies throughout the Orange County School District. While sharing his experience and encouraging young students to persevere through trials, he uses juggling and magic tricks to illustrate his arguments.

Beyond his local community, Kenslow is a published author and an online influencer. His first book, *Juggling the Issues: Living with Asperger's Syndrome*, was published in 2019. His second book, *Unstoppable*, was published in 2023 and explores his journey becoming a teacher with autism. "Matthew's latest book title captures his spirit and his mindset: Unstoppable," said Jeff Hittenberger, Ph.D., dean of Vanguard's School of Education. "Along his journey, many people underestimated Matthew's capacity to be a teacher, but at Vanguard he found a community that believes everyone can fulfill their God-given calling. We call this 'Education for Love and Wisdom.' Matthew embodies that vision, and he is making a profound and life-empowering difference in the lives of the students he serves."

Online, Kenslow has more than 1 million followers on Instagram, where he uses his platform to bring awareness to the experience of living with autism and encourages others to pursue their dreams despite their potential setbacks. "I hope [my advocacy] brings inclusion and people believing [in] themselves, selfconfidence, and [the encouragement] that people can do whatever they set their heart and mind to do, as long as it's practical and attuned to God's call," he shared.
